Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to SC/ST and Other Backward Communities included in the Short List are required to produce Community Certificate/Non Creamy Layer Certificate issued by the Revenue authority at the time of OTR Verification. The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the shortlist without further notice.

Note :- (7) Copy of answer scripts of the OMR Test held on **22-01-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Answer scripts of no candidates are invalidated as per Notification No : ER11(3)1010/2022/EW dated 17-03-2022.
