But Answerscripts will be rechecked if the candidates apply for through their One Time Registration profile from the Commission's official website www.kerala psc.gov.in by remitting the prescribed fee of **Rs.85** (Rupees Eighty Five only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered.
