Note (7):- Candidates included in the Probability List are required to produce Community Certificate in the case of SC/ST candidates , Non Creamy Layer Certificate in the case of candidates included in Other Backward Communities , EWS Certificate in the case of candidates included in Economically Weaker Section issued by the Revenue authority at the time of OTR Verification.

Note (8):- Copy of answer scripts of the OMR Test held on **30.11.2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
