- **NOTE (1)**:- According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply for through their One Time Registration profile from the Commission's official website www.keralapsc.gov.in by remitting the prescribed fee of Rs. 85/- (Rupees Eighty Five Only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered. A period of 15 (Fifteen) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the Date on which the Ranked List is uploaded in the website of the Commission (on or before **11/07/2023**)
- **NOTE (2)**:- Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed Fee of Rs. 335/- (Rupees Three Hundred and Thirty Five only) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates from the date on which the Ranked List is uploaded in the website of the Commission (on or before **11/07/2023**). Application submitted in any other manner will not be considered. A copy of answer sheet will be issued only once to a candidate. Copies of OMR sheets invalidated due to any defect will not be issued.
- **NOTE (3)**:- The entries put in column (5) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The candidates whose Communities have not been correctly noted in the Ranked List as proved by them in their Application should intimate the fact to the District Officer, Kerala Public Service Commission, District Office, Civil Station (P.O), Malappuram- 676505 within one month from the date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List
- **NOTE (5)**:- Since a common OMR test with common candidates was conducted for this post, the marks awarded to the candidates included in this Ranked List and marks of OMR test relating to all candidates appeard for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be finalised on the basis of the common test. The result of rechecking of OMR answer scripts will be intimated in due course. But photo copy of the OMR answer scripts will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test
