Note :- (5) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification and Practical Test will be published shortly.**

Note:- (6) The register number of candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short List without further notice.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Candidates belonging to Other Backward Classes included in the Short List are required to produce Non Creamy Layer Certificate as per GO(P) No-81/09/SC/ST/DD dated 26/09/2009 and SC/ST candidates are required to produce Community Certificate issued by the Revenue authority and candidate who claim EWS reservation are required to produce EWS certificate vide GO No. 2/2020 P&ARD dated 12/02/2020 at the time of OTR Verification.

Note :- (9) Copy of answer scripts of the OMR Test held on **29-10-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No :ER VIII(2)4890/22/EW dated 01/03/2023.
