NOTE (1):- For Online Examination rechecking and revaluation are not allowed. Candidates who wish to obtain a print out of their Answer sheets relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of Rs. 335(Rupees three hundred and thirty five) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for print out of answer sheet will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission. (ie,on or before 04/08/2023) Application submitted in any other manner (i.e via e.mail/Tappal/Direct) will not be considered. A copy of the answer sheet will be issued only once to a candidate.

NOTE (2):- The entries put in column (5) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The candidate whose Communities have not been correctly noted in the Ranked List as proved by them in their Application should intimate the fact to the within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.

NOTE (3):- The candidates who wish to relinquish their claim for advice from the Ranked list shall submit an application in the format prescribed by the Commission to District Officer, Kerala Public Service Commission District Office Thiruvananthapuram- 695004.. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office seal along with a Notarized Affidavit and self attested copy of an ID proof bearing Photograph as enlisted in the General Conditions. The request for relinquishment along with the original of notarized affidavit and a self attested copy of the ID proof received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List (ie,on or before 04/08/2023). After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of vacancy based on which he/she is to be advised.

NOTE (4):- Since a Common Online test was conducted for the post the marks awarded to the candidates included in the Ranked List and marks of online test relating to all candidates will be published only after publication of the entire Ranked List which will be finalised on the basis of common test, printout of the answer sheet will be issued once after the entire Ranked Lists for all posts are finalised on the basis of Common Test.
