- (i) A Ranked list will be prepared for Thiruvananthapuram District in pursuance of this notification. The Ranked List thus prepared and published by the commission, shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appoinment against the aforesaid vacancy and also against the vacancies, if any, reported during the currency of the list. In case no candidate is advised from the ranked list till the expiry of the period of three years, the duration of the ranked list shall be extended for a further period of one year or till atleast one candidate is advised from the list whichever is earlier.
- (ii) Candidates shall submit the application for this post to the above district, and shall note the name of that district against the relevant column in the online application.

Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.
