- (ii) Candidates should submit their application for this post to any of the above Districts, where the vacancy is existing and should note the name of that District against the relevant column of the online application. Applications should not be submitted to more than one District in response to this notification. If applications are submitted contrary to the above direction, and if he/she is selected, his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her.
- (iii) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in GO(Ms) No. 154/71/PD dated, 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another District unless he/she completes five years of continuous service from the date of commencement of service in the former District. Even if transfer is allowed after five years, it will be subject to the rules in GO(MS) No. 4/61/PD dated, 2.1.1961.
