Note :- (6) Candidates included in the Short List are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/09/SC/ST/DD dated 26/09/2009 and SC/ST candidates are required to produce Community Certificate issued by the Revenue authority and candidates who claim EWS reservation are required to produce EWS certificate vide G.O No.2/2020/P& ARD dated 12/02/2020 issued by the Revenue authority at the time of OTR Verification.

Note :- (7) The register number of the candidates who do not produce the required document within the prescribed time limit and whose application found otherwise defective will be deleted from the Short list without further notice.

Note :- (8) For online examination, rechecking and revaluation are not allowed but printout of answersheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of the Ranked list. Detailed instructions will be furnished in the Ranked list to be published for the post.
