**NOTE (1)** :- The Ranked List will be in force till the publication of new Ranked list after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. **NOTE (2)** - According to the existing procedure, revaluation of Answer Script is not allowed. A period of 15 (Fifteen) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the Date on which the Ranked List is uploaded in the website of the Commission.

**NOTE (3)** :- Candidates who wish to obtain a photocopy of their Answer Sheets (Part A &Part B) relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed Fee of Rs. 335/- (Rupees Three Hundred and Thirtyfive only) via. e-payment mode available in the portal. A period 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the from the date on which the Ranked List is uploaded in the Website of Commission . Applications submitted in any other manner (ie via E-mail/Tappal/Direct )will not be considered. A copy of Answer Sheet will be issued only once to a candidate. Copies of OMR sheet invalidated due to any defect will not be issued.

**NOTE (4)** :- The entries put in column (5) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The candidate whose Communities have not been correctly noted in the Ranked List as proved by them in their Application should intimate the fact to the Deputy Secretary (Examinations) - I, Kerala Public Service Commission, Thiruvananthapuram - 695004 within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.
