Applications are invited online only by One Time Registration exclusively from qualified candidates belonging to Scheduled Caste, Muslim communities of Kerala state for selection to the under mentioned post.

Note:- (i) The above vacancy is existing at present. The Ranked List published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked to the Scheduled Caste, Muslim Communities but remain unfilled due to the paucity of candidates during the currency of the Ranked List published on 05.08.2022 for the post as per Category No.149/2019.

(ii) The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidate to the above post, if it is subsequently found that such advice was made under some mistake. On such cancellation the appointing authority shall terminate the service of candidate, provided that, the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made within the period of probation or 240 days from the date of joining duty whichever is earlier.

5 Method of Appointment : Direct Recruitment from candidates belonging to Scheduled Caste, Muslim Communities only.

Note:- Applications submitted by candidates belonging to communities other than Scheduled Caste and Muslim Community will be summarily rejected. No rejection memo will be issued to these candidates.

6 Age limit : **a)** 18-41, Only candidates belonging to Scheduled Caste born between 02.01.1982 and 01.01.2005 (both dates included) are eligible to apply for this post (including relaxation as per para 2 (i) of the General Conditions). In no case the maximum upper age limit shall exceed 50 (fifty) years.

**b)** 18-39, Only candidates belonging to Muslim community born between 02.01.1984 and 01.01.2005 (both dates included) are eligible to apply for this post. (including relaxation as per para 2 (i) of the General Conditions). In no case the maximum upper age limit shall exceed 50 (fifty) years.

Note:- The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in subject to a maximum of Five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in

the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of their provisional service in the concern and shall produce the same as and when required by the Commission. It would also be clearly specified in the certificate that they were not working in the regular service of the concern.

**8. Mode of submitting Application:**

**a)** Candidates must register as per ONE TIME REGISTRATION with the official Website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded should be taken after 31.12.2013. Candidates who are creating profile from 01.01.2022 onwards, must upload photograph which is taken within 6 months. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. **Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application.** The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original documents to prove qualification, age, Community etc. have to be produced as and when called for.

**b)** If written/OMR/Online Test is conducted as part of this selection candidates possessing requisite qualification shall submit a **confirmation** for writing the examination through their One Time Registration profiles. Such candidates alone can generate and download the Admission Tickets in the

last 15 days till the date of Test. The application of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of admission tickets will be published in the examination calendar itself.
