If any of the documents produced by any candidate is found defective the Commission reserves the right for rejection of their candidature at any stage of selection as per rule.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) SC/ST candidates included in the Short list are required to produce Community Certificate (in Form III /Digitally Signed) issued by the concerned Revenue Authority. Candidates belonging to Other Reservation Groups should produce Non Creamy Layer Certificate and those who claimed EWS should produce relevant certificate issued by Village Officer at the time of OTV.

Note :- (7) Copy of answer scripts of the OMR Test held on **04-05-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Candidates are invalidated as per Notification : - ERVI(3)2403/2023/EW Dated 27.07.2023.
