**NOTE (2)** :-For Online Examinations rechecking and revaluation is not allowed. Candidates who wish to obtain a printout of their answer sheets relating to this selection shall submit online application through their One Time Registration profile from the official website www.keralapsc.gov.in by remitting the prescribed fee of Rs. 335/- (Rupees Three Hundred and Thirty Five only) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for printout of answer sheet will be allowed to candidates with effect from the date on which the Ranked list uploaded in the website of the commission. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. Applications received after the prescribed date will not be entertained. Applications submitted through email/by post/in person will not be considered.

Note (3)The entries put in column (8) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The candidate whose Communities have not beencorrectly noted in the Ranked List as proved by them in their Application should intimate the fact to the DeputySecretary (Examinations) -I, Kerala Public ServiceCommission, Thiruvananthapuram - 695004 within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.

NOTE (4) :- Candidates who wish to relinquish their claim for advise from the Ranked List shall submit an application in the format prescribed by the commission to THE SECRETARY,KERALA PUBLIC SERVICE COMMISSION HEAD OFFICE, PATTOM, THIRUVANANTHAPURAM-4. The format is available in the official website of the commission.
