For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Economically Weaker Section , Other Backward Classes necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present in person for **Physical Measurement. Date, time and Venue** of Physical Measurement will be intimated through Profile Message and SMS

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to SC/ST Community included in the Short List are required to produce Community Certificate issued by the Revenue authority and candidates belonging to Other Backward Classes included in the Short List are required to produce Non-Creamy Layer Certificate as per GO(P)No.81/09/SC/ST DD dated 26/09/2009 issued by the Revenue authority and candidates belonging to EWS category are required to produce EWS certificate issued by the Revenue Authority at the time of OT Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **17-05-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Answer scripts are invalidated as per Notification No : ER XVI(3)3634/2023/EW Dated 19/09/2023.
