**NOTE (2)** :- For ONLINE Examination rechecking and revaluation are not allowed. Candidates who wish to obtain a printout of their Answer Sheets relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission www.keralapsc.gov.in by remitting the prescribed fee of Rs. 335 (Rupees Three Hundred and Thirty Five) via e-payment mode available in the portal. A period of 15 days (Fifteen days) time to apply for print out of answer sheets will be allowed to candidate witheffect from the date on which the Ranked list is uploaded in the website of the Commission (ie on or before 29.11.2023) . Application submitted in any other manner (ie via email/Tappal/Direct) will not be considered . A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for printout of the answer sheet which is not their own, and legal proceedings wil be initated against those who do so. Printout of the answer sheet will be issued only after the publication of the Ranked list for all the posts finalised on the basis of the common test.

**NOTE (3)** :- Since a common Online Test with common candidates was conducted for this post, the marks awarded to candidates included in this Ranked list and mark of Online test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA notification if any) which will be finalised on the basis of the common test.

**NOTE (4)** :- The entries put in column (5) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The candidate whose Communities have not been correctly noted in the Ranked List as proved by them in their Application should intimate the fact to the Deputy Secretary (Examinations) -I, Kerala Public Service Commission, Thiruvananthapuram - 695004 within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to.
