For the purpose of satisfying of rules of reservation of appointments to Scheduled Castes, Scheduled tribes, Other Backward Classes (and other reserved categories if any) necessary supplementary list is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes .

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be published shortly.**

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) SC/ST Candidates included in the Short List are required to produce Community Certificate issued by the Revenue authority at the time of OTR Verification. Candidates belonging to other reservation groups should produce Non-creamy layer certificate and those who claimed EWS should produce relevant certificate issued by Village Officer at the time of OTR Verification

Note :- (7) Copy of answer scripts of the OMR Test held on **02-06-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Candidates are invalidated for the above mentioned post as per the invalidation Notification No :ERVII(2) 3258/2023/EW dated 04.09.2023.
