Note :- (3) **19 (Nineteen)** candidates who have secured top most marks in the Main OMR examination are included in the Main List of this Short list. The Marks secured by the last candidate in the Main List is **72.33 (seventy two (point) three three)** marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and other reserved categories ,if any necessary Supplementary List is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should be present in person for Physical Measurement . Date,time and Venue of Physical Measurement will be intimated through SMS, Profile message and through Print and Electronic Media. The shortlisted candidates should download their Admission Tickets for the Physical Measurement from their OTR profiles logging on to the official website- www.keralapsc.gov.in of the Kerala Public Service Commission and appear for the test with necessary documents.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List who belong to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by Village Officer as per GO(P) No.81/09/SCSTDD dated. 26.09.2009, SC/ST candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce EWS Certificate issued by Village Officer as per GO(Ms) No 2/2020/P&ARD dated 12/02/2020 along with other documents at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the Main OMR Test held on 17-05-2023 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
