Note:- (4) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be published shortly.**

Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) SC/ST candidates included in the Probability List are required to produce Community Certificate issued by the Revenue Authority at the time of OTR Verification.Candidates belonging to other reservation groups should produce Non Creamy Layer Certificate and those who claimed EWS should produce relevant certificate issued by the village officer at the time of OTR verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **19-06-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Answer scripts of no candidates are invalidated as per Notification No : ER VII (3)3252/2023/EW Dtd 21.09.2023
