Date ,Time, and Venue of the said Test will be intimated in due course through SMS and profile Message. The shortlisted candidates should download their Admission Tickets for the above test from their OTR profiles ,logging on to the official website "www.keralapsc.gov.in" of Kerala Public Service Commission and appear for the test with necessary documents. The shortlisted candidates are directed to produce a Medical certificate (in the form prescribed as per the notification) issued by a Medical Officer not below the rank of Assistant Surgeon/Junior Consultant at the time of Physical Measurement and Physical Efficiency Test.

Note :- (4)The Physical Measurements of candidates will be taken prior to the Physical Efficiency Test and those who do not possess the prescribed physical measurement will not be admitted for the Physical Efficiency test. If accidents or injuries happen to a candidate while participating in the Physical Efficiency Test, he will not be given further chance to participate in the test.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List who belong to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by Village Officer as per GO(P) No.81/09/SCSTDD dated. 26.09.2009,SC/ST Candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Thasildar and candidates claiming reservation under EWS category are required to produce EWS Certificate issued by Village Officer as per GO(Ms) No.2/2020/P&ARD dated 12.02.2020 along with other documents at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on 19-05-2023 will be issued to those candidates who apply for the same remitting the prescribed fee after approval of the Ranked List.
