For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Economically Weaker Section , Other Backward Classes necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be published in due course.**

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short list, belonging to SC/ST/OBC/EWS community / Category are required to produce Community Certificate/ Non Creamy Layer Certificate/EWS Certificate issued by the Revenue authority along with the other documents at the time of verification of Original documents..

Note :- (7) Copy of answer scripts of the OMR Test held on **13-07-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No candidates are invalidated as per Notification No : .ERXV(1)3883/2023/EW dated 21.09.2023
