The following is the list of candidates for selection to the post of **PHARMACIST Gr.II (Ayurveda) (First NCA - MUSLIM) on Rs.27,900 – 63,700/-** in **Indian Systems of Medicine/Insurance Medical Services/ Ayurveda Colleges in Kannur District** and found suitable by the Commission and arranged in the order of merit based on the **Online Examination held on 08.08.2023**. This Ranked List is brought into force with effect from **25.01.2024** and will be valid until the candidates are advised and appointed against the vacancies kept unfilled due to the paucity of candidates belonging to Muslim community during the currency of the mother ranked list published on 17/11/2021 (Cat No.531/2019) for the post.

NOTE (1) :- For online examination rechecking and revaluation is not allowed. Candidates who wish to obtain print out of Answer sheets relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of Rs. 335/- (Rupees three hundred and thirty five) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for print out of Answer sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission (**i.e on or before 14.02.2024**). Application submitted in any other manner i.e, email/Tappal/Direct will not be considered. A print out of Answer sheets will be issued only once to a candidate. Print out of Answer sheets will be issued only after the publication of the Ranked List for all the posts finalized on the basis of common test.

NOTE (2) :-The entries put in column (5) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The candidate whose Communities have not been correctly noted in the Ranked List as proved by them in their Application should intimate the fact to The District Officer, Kerala Public Service Commission ,District Office, Kannur-2 within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.

NOTE (3) :- The candidate who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the commission to The District Officer, Kerala Public Service Commission ,District Office, Kannur-2 .The format is available in the official website of the commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the commission will not be honoured under any circumstances.The request for relinquishment should be duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the general conditions. The request for relinquishment along with the original of notarized affidavit and self attested copy of the ID proof received within 15 days from the date of publication of Ranked List in the official website of the commission will be honoured against the requisitions of vacancies that are pending with the commissions up to the finalization of the Ranked List. After the publication of Ranked List ,the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition,based on which he/she is to be advised.

NOTE (4) :- Since a common test with common candidates was conducted to this post, the mark awarded to the candidates included in the Ranked List and mark of the test relating to all candidats appeared for the test will be published only after the publication of entire ranked list (including NCA notification) which will be finalized on the basis of the common test.
