Note :- (2) The Short list has been prepared by including the number of candidates who have secured top marks in the OMR Test based on the details furnished by the candidate in application and subsequent claims made will not be entertained at any stage.

Note :- (3) 10(Ten) candidates who have secured top most marks in the OMR examination are included in the Main list of the short list. The marks secured by the last candidate in the Main list is 57(Fifty Seven). For the purpose of satisfying of rules of reservation of appointments to Scheduled Castes, Scheduled Tribes, other Backward Classes and Economically Weaker Section necessary supplementary list is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should be present and produce in person the original documents for One Time Verification and interview . Date, time and Venue of OTR Verification and Interview will be intimated through profile message and SMS.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O.(P) No. 81/2009/SCSTDD dated 26.09.2009, SC/ST candidates are required to produce a Community Certificate in Form III or digitally signed certificate issued by the Revenue Authority not below the rank of Tahasildar & EWS Certificate in case of candidates having EWS reservation in the format prescribed vide G.O.(Ms.)No:02/2020/P&ARD dated 12.02.2020 issued by the Revenue Authority at the time of OTR Verification.

Note :- (7) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the short list without further notice.

Note :- (8) Copy of answer scripts of the OMR Test held on 16-08-2023 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. The answer scripts of no candidates are invalidated for the above mentioned post.
