Note :- (6) Candidates belonging to Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O.(P) No. 81/2009/SCSTDD dated 26.09.2009, SC/ST candidates are required to produce a Community Certificate in Form III or digitally signed certificate issued by the Revenue Authority not below the rank of Tahasildar & EWS Certificate in case of candidates having EWS reservation in the format prescribed vide G.O(Ms.)No:02/2020/P&ARD dated 12.02.2020 issued by the Revenue Authority at the time of OTR Verification.

Note :- (7) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the short list without further notice.

Note :- (8) Copy of answer scripts of the OMR Test held on 16-08-2023 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. The answerscripts of no candidates are invalidated for the above mentioned post.
