Note:- (4) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be intimated shortly.**

Note:- (5) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found other wise defective will be deleted from the Probability List without further notice.

Note:- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Candidates belonging to Other Backward Classes, included in this List, are required to produce Non-Creamy Layer certificate as per G.O (P) No.81/2009/SCSTDD Dated 26.09.2009 issued by Village Officer,SC/ST candidates,included in the List,are required to produce Community Certificate (Form III or digitally signed) issued by the Revenue authority not below the Rank of Tahsildar and candidates who claim EWS Reservation are required to produce EWS certificate issued by Revenue authority ,along with other documents at the time of OTR Verification.

Note :- (8) Copy of answer scripts of the OMR Test held on **11-07-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER11(3)4006/2023/EW Dated 18/11/2023 .
