Note :- (2) The list has been prepared by including the number of candidates who have secured top marks in the OMR Test.

Note :- (3) 56 (Fifty-six) candidates who have secured topmost marks in the OMR Examination are included in the Main list of this Short List. The Marks secured by the last candidate in the Main list is 53.67 (Fifty-three point Six Seven) marks. For the purpose of satisfying the Rules of Reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes, EWS, Differently abled candidates necessary supplementary lists are prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be published shortly.**

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List are required to produce NCLC/Community Certificate/EWS Certificate, as the case may be, issued by the Revenue authority and Differently Abled candidates are required to produce Medical Certificate at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **19-07-2023** will be issued to those candidates who apply for the same remitting the prescribed fee after approval of the Ranked List. No Candidate has been invalidated as per Notification No : ER(OSM)/4271/2023/EW dated 27.02.2024
