The Marks secured by the last candidates in the Main List is **59.67 (fifty nine (point) six seven)** marks .For the purpose of satisfying the rules of reservation of appointment to Scheduled caste, Scheduled Tribe, Other Backward Classes (and other reservation Categories if any) necessary supplementary list is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (3) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be intimated in due course.**

Note:- (4) The Short List is prepared based on the details furnished by the candidates in the application and subsequent claim will not be entertained at any stage.

Note:- (5) The Register number of those candidates who do not produce required documents within the prescribed time and those application found otherwise defective will be deleted from Short list without further notice

Note:- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) SC/ST Candidates included in the Short List are required to produce Community Certificate (Form III or Digitally Signed) issued by the Revenue authority and other reservation groups are required to produce Non Creamy Layer Certificate /EWS Certificate at the time of OTR Verification along with other documents

Note :- (8) Copy of answer scripts of the OMR Test held on **19-04-2023** will be issued to those candidates who apply for the same remitting the prescribed fee after approval of the Ranked List.
