NOTE (1) :- The entries put in column (5) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal along with a notarized affidavit and a self attested copy of an ID Proof bearing photograph as enlisted in the General conditions. The request for relinquishment along with the original of notarized affidavit and self attested copy of an ID proof received within **15 days** from the date of publication of Ranked List in the Official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised.

NOTE: (3) Since a Common Online test with Common candidates was conducted to this Post, the mark awarded to the candidates included in the Ranked List and mark of test relating to all candidates appeared for the test will be published only after the publication of entire Ranked List (including NCA Notification) which will be finalized on the basis of the common test.

NOTE: (4) Candidates who wish to obtain a print out of their Answer sheets relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of Rs. 335 (Rupees three hundred and thirty five) only via e-payment mode available in the portal. Application submitted in any other manner will not be considered. A copy of the answer sheet will be issued only once to a candidate.
