The following is the list of candidates for selection to the post of **COOK (FIRST NCA-OBC) (Cat.No.713/2021)** on **Rs.16500-35700 /- (PR)** in **SCHEDULED CASTE DEVELOPMENT DEPARTMENT** in **MALAPPURAM DISTRICT** and found suitable by the Commission and arranged in the order of merit on the basis of the **Common OMR Test held on 15/12/2023** for recruitment against the NCA vacancies for Other Backward Community. This NCA Ranked List is brought in to force with effect from **28/05/2024** and will be valid until the candidates are advised and appointed against the vacancies notified due to the paucity of candidates belonging to Other Backward Community during the currency of the Mother Ranked List published on **26/07/2017(Cat.No.566/2013)** for the post.

NOTE (1) :- According to the existing procedure, revaluation of Answer script is not allowed. But Answer scripts will be rechecked if the candidates apply for through their One Time Registration profile from the Commission's official website www.keralapsc.gov.in by remitting the prescribed fee of **Rs.85** (Rupees Eighty-Five only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered. A period of 15 (Fifteen) days time to apply for rechecking of Answer scripts will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission ie. on or before **18/06/2024**.

NOTE (2):- Candidates who wish to obtain a photocopy of their OMR Answer sheets (Part A & Part B) relating to the selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of **Rs.335** (Rupees Three Hundred and Thirty-Fiveonly) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission ie. on or before **18/06/2024**. Application submitted in any other manner will not be considered. A copy of the answer sheet will be issued only once to the candidate. Copies of OMR sheets invalidated due to any defect will not be issued

.NOTE (3) :- The candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission to **the District Officer, Kerala Public Service Commission District Office, Civil Station P O, Malappuram-676 505..** The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal along with a notarized affidavit and a self attested copy of an ID Proof bearing photograph as enlisted in the General conditions. The request for relinquishment along with the original of notarized affidavit and self attested copy 1of an ID proof received within 15 days from the date of publication of Ranked List in the Official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised.

Note: (4) 1) Since a Common OMR test with Common candidates was conducted to this Post, the mark awarded to the candidates included in the Ranked List and mark of test relating to all candidates appeared for the test will be published only after the publication of entire Ranked List (including NCA Notification) which will be finalized on the basis of the comon test. 2) The result of rechecking of OMR anwser scripts will be initated in due course. But photocopy of OMR answer script will be issued only after the publication of the Ranked List for all the posts finalized on the basis of the common test.

NOTE (5):- The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of Ranked list.
