Note :- (5) Scheduled Caste candidates included in the short list are required to produce Community Certificate in Form III or digitally signed issued by the Revenue Authority and candidates belong to other reservation groups should produce Non Creamy Layer or EWS Certificate as the case may be at the time of OTR Verification.
