Hence 7 OC & 8 Reservation turns which got additional benefit of advice from previous Ranked List has to be de-reserved as per the order of the Hon'ble Commission. Out of the 8 Reservation turns all except SCCC has been dereserved in this rotation. NJD in respect of MR IV 44 ST & MR IV 52 SC (Advised on 18.10.2023 & 07.11.2023 (From Previous R/L)) has been reported twice. Being NJD the advice was not effective and no double benefit is received & one SC & One ST turns are to be filled without mentioning already filled. Hence the two NJD vacancies (in respect of MR IV 44 ST & MR IV 52 SC advised on 07.11.2023) are treated as fresh as per order of the Hon'ble Commission. ST turn has been filled in this rotation and one SC turn to be filled in coming rotation.
