NOTE (1) :-10% of vacancies which are reported to the district office of the Public Service Commission will be filled up by candidates selected from low paid employees in the subordinate services. The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered. A period of 15(Fifteen) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission (i.e., on or before 19.06.2024)

NOTE (3) :- Candidates who wish to obtain a photocopy of their OMR Answer Sheets (part A & part B) relating to this selection shall submit online application through their One Time Registration Profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed Fee of Rs. 335/- (Rupees Three Hundred and thirtyfive only) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission (i.e., on or before 19.06.2024). Application submitted in any other manner will not be considered. Acopy of the answer sheet will be issued only once to a candidate. Copies of OMR sheets invalidated due to any defect will not be issued.

NOTE (4) :-The candidates who wish to relinquish their claim for advice from the RankedList shall submit an application in the format prescribed by the Commission to District Officer, Kerala Public Service Commission District Office, Kasaragod-671121. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment in the prescribed format along with the original of notarized affidavit and self attested copy of an ID proof received within 15 days from the dateof publication of Ranked List in the Official website of the Commission will be honoured against the requisitions of theRanked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised.

NOTE (5) :-Since a common Objective Type (OMR valuation) test was held for this post, the marks awarded to the candidates included in the Ranked List and marks of OMR Test relating to all the candidates appeared for the test will be published only after the publication of all the Ranked Lists (including NCA Ranked Lists) which will be finalised on the basis of the common test . The result of rechecking of OMR scripts will be intimated in due course. But photocopyof OMR sripts will be issued only after the publication of all the Ranked Lists of all the Ranked Lists to be finalised on the basis of the common test for each post.
