Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Probability List ,eligible for reservation are required to produce Non Creamy Layer Certificate as per G.O.(P) No. 81/09/SC/ST/DD dated 26.09.2009 /Community Certificate issued by the Revenue authority / EWS Certificate as per G.O.(MS)No.02/2020/P&ARD dated 12/02/2020, shall produce the same along with the other documents at the time of OTR verification of original documents.

Note :- (7) Copy of answer scripts of the OMR Test held on **03.01.2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : **ER2A2/2/2024-KPSC** dated **20.03.2024**.
