Note :- (6) The Physical Measurement and Physical Efficiency Test followed by a Swimming test as specified in the Gazette Notification will be conducted before the publication of Ranked list. Date, time and Venue of Physical Measurement and Physical Efficiency Test and Certificate Verification will be intimated in due course by SMS / Profile message. Candidates should download their Admission Tickets for Physical Measurement and Physical Efficiency Test from their One Time Registration Profile and appear in person with their original ID Proof.
