Note :- (4) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (5) Candidates included in the Short List who qualify in physical Measurement, Physical Efficiency Test, Swimming Test are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/2009/SCSTDD dated 26/09/2009 issued by Village officer in the case of Other Backward Classes, and SC/ST candidates, included in the List, are required to produce Community Certificate (Form III or digitally signed) issued by the Revenue authority not below the rank of Tahsildar and candidates who claim EWS reservation are required to produce EWS certificate vide GO (M S) No 2/2020/P&ARD dated 12/02/2020 issued by the Revenue Authority, and Medical certificate in the prescribed form as per Gazette Notification obtained from a Medical officer not below the rank of a Civil Surgeon along with other documents at the time of OTR verification.

Note :- (6) Copy of answer scripts of the OMR Test held on **10-02-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
