NOTE (1) :- The Ranked List will be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates from the Ranked List will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the Ranked List. NOTE (2):- According to the existing procedure, revaluation of Answer Script is not allowed. The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered. A period of 15 (Fifteen) days to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which the Ranked list is uploaded in the website of the Commission(i,e. on or before 09.08.2024). The candidates can avail only one chance after the approval of Ranked List. Rechecking of invalidated answer scripts due to any defects will not be considered. Fee once remitted will not be refunded. Applications submitted through email/by post /in person will not be considered.

NOTE (3):- Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration profile from the official website of the commission www.keralapsc.gov.in by remitting the prescribed fee of Rs.335/- (Rupees Three Hundred and Thirty Five only) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked list uploaded in the website of the Commission(i,e. on or before 09.08.2024) . A copy of the answer sheet will be issued to a candidate only once. Copies of OMR answer sheets invalidated due to any defect will not be issued. Applications submitted through email/by post/in person will not be considered.

NOTE (4) :- The result of rechecking of OMR answer scripts will be intimated in due course. But photocopy of the OMR answer scripts will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test.

NOTE (5) :- The entries put in column (4) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The candidate whose Communities have not been correctly noted in the Ranked List as proved by them in their Application should intimate the fact to the Deputy Secretary (Examinations) -III, Kerala Public Service Commission, Thiruvananthapuram - 695004 within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. The request for relinquishment along with a Notarized Affidavit and a self attested copy of the ID Proof received within 15 days from the date of publication of Ranked List in the Official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of vacancy, based on which he/she is to be advised.
