The mark secured by the last candidate in the Main List is 37.33 (thirty seven(point) three three) marks .Candidates included in the Probability List are required to produce Community Certificate issued by the Revenue authority at the time of OTR Verification. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes,Scheduled Tribes, Other Backward Classes and Economically Weaker Section Category, if any, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be will be intimated through profile message and SMS.**

Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) SC/ST candidates included in the Probability List are required to produce Community Certificate(in FormIII / Digitally Signed) issued by the competent Revenue Authority, candidates belonging to Other Reservation Groups are required to produce Non Creamy Layer Certificate issued by the Village Officer as per G.O(P) No 81/2009/SC/STDD dated 26.09.2009 and those belonging to Economically Weaker Section Category are required to produce EWS certificate in the format prescribed vide GO(MS) No 23/2022/P&ARD dated 04/10/2022 in proof of their claim along with other relevent documents at the time of OTR Verification of original documents..

Note :- (7) Copy of answer scripts of the OMR Test held on **04-04-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List . No Answer Scripts of Candidates are invalidated as per Notification No : ER16-2/1/2024-KPSC dated 11.06.2024
