Note :- (2) The list has been prepared by including the number of candidates who have secured top marks in the OMR Examination held on 29.04.2024.

Note :- (3) 10 (Ten) candidates who have secured top most marks in the OMR Examination are included in the Main List of the Short List. The marks secured by the last candidate in the Main List is **41.67 (Forty One (Point) Six Seven)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Section necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) The Short List is prepared based on the details furnished by the candidates in the application and subsequent claim will not be entertained at any stage.

Note :- (5) Candidates included in the Short List should present and produce in person the original documents for OneTime Verification and interview. Date, time and Venue of OTR Verification and Interview will be published shortly.

Note:- (6) The Register number of those candidates who do not produce required documents within the prescribed time and those application found otherwise defective will be deleted from Short List without further notice.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Candidates belonging to other backward classes included in the Short List are required to produce NonCreamy Layer Certificate, as per G.O(P)No.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in G.O(Rt) No 3942/2018/RD dated 24.09.2018 and SC/ST candidates are required to produce Community Certificate issued by the Revenue Authority and candidates who claim EWS reservation are required to produce EWS Certificate vide G.O(MS)No.2/2020/P&ARD dated 12.02.2020 issued by the revenue Authority along with other documents at the time of OTR verification of original documents.

Note :- (9) Copy of answer scripts of the OMR Examination held on 29.04.2024 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER 16-2/7/2024-KPSC Dated 25.07.2024.
