For the purpose of satisfying the rules of reservation of appointment to Scheduled castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any), necessary Supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be intimated in due course.**

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) The short list is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note :- (7) Candidates belonging to other backward classes included in the Short List are required to produce Non Creamy Layer Certificate, SC/ST candidates are required to produce community certificates in Form III or digitally signed issued by Revenue Authority and candidates belonging to Economically Weaker Section (EWS) included in this list are required to produce certificate issued by the Revenue authority at the time of OTR Verification.

Note :- (8) Copy of answer scripts of the OMR Test held on **03-04-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Candidates are invalidated for the post as per Invalidation Notification No: **ER2-2/4/2024-KPSC dated 27/06/2024.**
