**NOTE (5):-** The entries put in column (5) are based on the Communities specified by the candidate in their application forms and proved by them with necessary documents. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.

After the publication of the Ranked List the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised.
