Note :- (6) Candidates belonging to SC/ST included in the Short List are required to produce Community Certificate issued by the competent Revenue Authority and candidates belonging to Other Reservation Groups are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/2009/SCSTDD dated 26/09/2009 issued by Village officer/EWS Certificate vide GO (M S) No 2/2020/P&ARD dated 12-02-2020 issued by the Village Officer in proof of their claim along with other relevant documents at the time of OTR Verification of original documents.

Note :- (7) For Online Examination ,rechecking and revaluation are not allowed but print out of the answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of the Ranked List. Detailed instructions will be furnished in the Ranked list to be published for the post.
