Date,Time and Venue of the One Time Verification will be intimated to the candidates in due course

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to the Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O.(P) No. 81/2009/SCSTDD dated 26.09.2009 , SC/ST candidates are required to produce a Community Certificate either in Form III or digitally signed certificate issued by the Revenue Authority not below the rank of a Tahsildar and an EWS Certificate issued by the village officer in case of candidates having EWS reservation at the time of One Time Verification

Note :- (7) Copy of answer scripts of the OMR Test held on 08-05-2024 will be issued to those candidates who, apply for the same remitting the prescribed fee, after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to notification no ER7-3/15/2024-KPSC dtd 25/07/2024 of The Secretary,KPSC,Thiruvananthapuram.
