Note :-(2) The Short list has been prepared by including the requisite number of candidates on the basis of the marks secured in the Common OMR Test held on 29/04/2024 based on the details furnished by candidate in the Application and subsequent claim , if any , will not be entertained at any stage .

Note:- (3) 20(TWENTY) candidates who have secured top most marks in the OMR Examination are included in the Main List of this Short List. The Marks secured by the last candidate in the Main List is 38.67 (Thirty eight(point) six seven) marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Section , necessary Supplementary List is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) Candidates included in the Short List should be present in person and produce the original documents for One Time Registration Verification and Interview. Date, Time and Venue of OTR Verification and Interview will be intimated through profile message and SMS.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post.

Note:- (6) SC/ST candidates included in the Short List are required to produce Community Certificate(in Form III/Digitally Signed) issued by the competent Revenue Authority, candidates belonging to Other Reservation Groups are required to produce Non Creamy Layer Certificate issued by the Village Officer as per G.O(P) No 81/2009/SCSTDD dated 26.09.2009 and those belonging to Economically Weaker Section Category are required to produce EWS certificate in the format prescribed vide GO(MS) No 02/2020/P&ARD dated 12/02/2020 in proof of their claim along with other relevant documents at the time of OTR Verification of original documents.

Note :- (7) Copy of answer scripts of the OMR Test held on 29-04-2024 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER 16 - 2/7/2024 - KPSC dated 25/07/2024.
