The marks secured by the last candidate in the Main List is 92 (Ninety Two). For the purpose of satisfying rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) necessary supplementary lists is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should be present in person for Practical Test with the original ID proof and admission ticket issued for the said test .Date,time and Venue of Practical Test will be intimated through Profile Message and SMS.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes, included in this List, are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/2009/SCSTDD dated 26/09/2009 issued by Village officer and SC/ST candidates, included in the List, are required to produce Community Certificate (Form III or digitally signed) issued by the Revenue authority not below the rank of Tahsildar and candidates who claim EWS reservation are required to produce EWS certificate vide GO(MS) No 2/2020/P&ARD dated 12-02-2020 issued by the Revenue Authority, along with other documents at the time of OTR verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **20-05-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts of candidates are invalidated as per Notification : ER 4-1/10/2024-KPSC Dt. 11.09.2024.
