Note :- (3) 21 (Twenty One) candidates who have secured top most marks in the OMR Examination are included in the Main List of this Short List. The marks secured by the last candidate in the Main List is 41.33(Forty One (Point) Three Three) marks. For the purpose of satisfying the rules of reservation of appointment to Schedule Castes, Scheduled Tribes, Other backward classes (and other reserved categories if any) necessary supplementary list is prepared by including all eligible and qualified candidates from lower mark ranges in the order of merit of the candidates belonging to such classes

Note :- (4) At the next stages of selection process, there will be a Practical Test for the candidates included in this list. Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification and Practical Test will be published shortly.**

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes included in the list are required to produce Non Creamy Layer Certificates as per GO(P) No. 81/09/SCSTDD dated 26.09.2009 issued by Village Officer and SC/ST candidates included in the list are required to produce Community Certificate by the Revenue Authority not below the rank of Tahasildar and candidates who claim EWS reservation are required to produce EWS Certificate vide GO(MS)No. 23/2022/P&ARD dated 18/10/2022 issued by the Revenue Authority along with other documents at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **27-11-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : .ER VI 3/1/2024-KPSC Dated 18/03/2024
