The mark secured by the last candidate in the Main List is **48.67.(Forty Eight (point) Six Seven)** . For the purpose of satisfying the rules of reservation of appointment to Scheduled Caste, Scheduled Tribes, Other Backward Classes (and the other reserved categories if any) necessary Supplementary List is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4). The Probability List is prepared based on the details furnished by the candidates in the application and subsequent claims made will not be entertained at any stage.

Note:- (5). Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. Date, time and Venue of OTR Verification will be published shortly.

Note:- (6). The Register numbers of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Probability List without further notice.

Note:- (7) . According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8). Candidates included in the Probability List are required to produce Non Creamy Layer Certificate as per GO(P) No.81/09/SC/STDD dated. 26.09.2009, SC/ST Candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce EWS Certificate issued by Village Officer as per GO(Ms) No.2/2020/P&ARD dated 12.02.2020 along with other documents at the time of OTR Verification.

Note :- (9). Copy of answer scripts of the OMR Test held on 14.05.2024 will be issued to those candidates who, apply for the same remitting the prescribed fee, only after the publication of entire Ranked Lists which will be finalised on the basis of the common test. No candidates are invalidated for the post as per Notification No: ER2-3/13/2024-KPSC dated 13-08-2024.
