Note:- (4) Candidates included in the Probability List should present and produce the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be published in due course.**

Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) SC/ST candidates included in the Probability List are required to produce Community Certificate (in Form III / Digitally Signed) issued by the competent Revenue Authority, candidates belonging to Other Reservation Groups are required to produce Non Creamy Layer Certificate issued by the Village Officer as per G.O(P) No 81/2009/SC/STDD dated 26.09.2009 and those belonging to Economically Weaker Section Category are required to produce EWS certificate in the format prescribed vide GO(MS) No 02/2020/P&ARD dated 12/02/2020 in proof of their claim along with other relevant documents at the time of OTR Verification of original documents.

Note :- (7) Copy of answer scripts of the OMR Test held on **14-05-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : . ER-2-3/13/2024-KPSC dated. 13.08.2024 of the Secretary KPSC , Thiruvananthapuram.
