Note :- (1) Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of application on absolute basis. Inclusion of Register numbers in the Short List does not confer any right on the candidate for inclusion in the Ranked List. Note :- (2) **10 (Ten)** candidates who have secured topmost marks in the OMR Examination are included in the Main List of this Shortlist. The marks secured by the last candidate in the Main List is **36.67 (thirty six (point) six seven)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Caste, Scheduled Tribe, Other Backward Classes and other reserved categories, necessary supplementary lists is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes

Note :- (3) Candidates included in the Short List should be present in person and produce the original documents for One Time Verification. **Date, time and Venue of OTR Verification will be published shortly.**

Note :- (4) Candidates included in the Probability List and belonging to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by Village Officer as per GO(P) No.81/2009/SCSTDD Dtd.26.09.2009, SC/ST Candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar and the Candidates claiming reservation under EWS category are required to produce Income and Asset certificate issued by Village Officer as per GO (Ms) No. 2/2020/P&ARD Dtd. 12.02.2020 as proof of their claim, along with other relevant documents at the time of One Time Verification.

Note :- (5) The Short List is prepared based on the details furnished by the candidate in the application for the post and subsequent claims made will not be entertained at any stage.

Note :- (6) The register number of candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Short List without further notice.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Copy of answer scripts of the OMR Test held on **26-02-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER9-2/3/2024 KPSC dated 30.05.2024
