Note (2) :- The list has been prepared by including the number of candidates who have secured top marks in the OMR Test. The Short List has been prepared based on the details furnished by the candidate in the Application and subsequent claims, if any, made will not be entertained at any stage of the selection.

Note (3) :- **10** (Ten) candidates who have secured top most marks in the OMR Examination are included in the MainList of the Short List.The marks secured by the last candidate in the Main List is **61.33** ( sixty one (point) three three). For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes, Economically Weaker Section, 4% list for differently abled candidates , necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note (4) :- Candidates included in the Short List should present and produce in person the original documents for One Time Verification and Interview. Date, Time and Venue of OTR Verification and Interview will be intimated through Profile/SMS.

Note (5) :- According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note (6) :- Candidates included in the Short List belonging to Other Backward Classes are required to produce NonCreamy Layer Certificate issued by Village Officer as per GO(P) No.81/2009/SCSTDD Dtd.26.09.2009, SC/STCandidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce Income and Asset certificate issued by Village Officer as per GO (Ms) No. 2/2020/P&ARD Dtd. 12.02.2020 as proof of their claim, along with other relevant documents at the time of OTR Verification

Note (7) :- Copy of answer scripts of the OMR Test held on **28-11-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER4B1/5/2024-KPSC dated 27.05.2024.
