Note:- (7) Candidates belonging to Other Backward Classes included in this probability list are required to produce Non Creamy Layer Certificate as per GO(P) No.81/09/SC/STDD Dated .26.09.2009 and candidates belonging to EWS are required to produce EWS certificate vide GO(MS) No.2/2020/P&ARD dated 12.02.2020 issued by the concerned authority at the time of OTR verification.

Note :- (8) Copy of answer scripts of the OMR Test held on 23-04-2024 will be issued to those candidates ,who apply for the same remitting the prescribed fee,only after the publication of entire Ranked Lists which will be finalised on the basis of the common test.
