A period of 15 ((Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked Listis is uploaded in the website of the Commission (ie, on or before **09/11/2024**). Application submitted in any other manner will not be considered. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR sheets invalidated due to any defect will not be issued.

NOTE (4) :-The candidates who wish to relinquish their claim for advice from the RankedList shall submit an application in the format prescribed by the Commission to **District Officer**, **Kerala Public Service Commission District Office**, **Pathanamthitta**. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment along with the original of notarized affidavit and self attested copy of an ID proof received within 15 days from the date of publication of Ranked List in the Official website of the Commission upto the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised.
